**Terms of Agreement** I understand that by paying the \$125 Registration fee that I am intending to enroll my child \_\_\_\_\_ for the 2022-2023 school year. The fall semester begins on Tuesday, September 6, 2022 and ends on Thursday, December 15, 2022. The spring semester begins on Monday, January 9, 2023 and ends on Thursday, May 18, 2023.
